Student Support Services can provide assistance in the decision-making process to students affected by sexual violence, including sexual assault, relationship violence, and stalking. Services are confidential to the extent allowed by law. Student Support Services will assist you in filing a report to the Milwaukee Police Department and are required to do so by law.

*Student Support Services can provide upon request:*

- Referrals to Marquette University and community service providers
- Assistance with housing, academic, and other related concerns
- Information about reporting options
- Assistance with obtaining restraining orders and no-contact orders
- Assistance and support throughout the student conduct process
- Assistance and support throughout the criminal justice process

## **The Milwaukee LGBT Community Center**

Provides assistance to LGBTQ+ individuals who have experienced or otherwise been impacted by intimate partner violence, sexual assault and abuse, stalking, physical assault, harassment, bullying, bias-related incidents, hate crimes and other forms of violence by advocating on their behalf, assisting with crime reporting and accompanying crime victims to medical exams or court appearances if requested. A trained mental health professional is available by appointment to assist victims and survivors in stabilization following a sexual assault, an incident of partner violence, hate crime, or another traumatic event, whether recent or resurfacing.
